



# Nyiaj Tu menyuam Parenting Payment

Parenting Payment yog ib yam nyiaj tu menyuam ntawm muab pab rau cov niam thiab txiv los yog tus neeg saib-xyuas menyuam (tsom kwm).

## Cov neeg muaj cai txais Parenting Payment

Cov nyiaj Parenting Payment yog them rau tus neeg uas tus menyuam nyob nrog. Nws tsuas them rau tib tug neeg xwb xwsli leej niam losyog leej txiv los yog tus neeg saib-xyuas tus menyuam uas (guardian) uas tus me nyuam nyob nrog. Yog hais tias koj yog ib leej niam thiab txiv, pog thiab yawg, los yog ib tug niam-qhuav txiv qhuav, Koj muaj cai txais tau cov nyiaj Parenting Payment thiab yog hais tias:

- Koj tsis muaj txiv/pojniam thiab tseem muaj ib tus menyuam hnuv nyoog qis tshaj yim xyoo nrog nyob, los yog
- Koj muaj txiv/pojniam thiab tseem muaj ib tus me nyuam hnuv nyoog qis tshaj rau xyoo nrog nyob thiab
- Neb ob niam-txiv (yog tias koj muaj txij-nkawm) cov nyiaj thiab khoom vaj khoom tsev (assets) muaj tsawg tshaj qhov ntawm tus kevcai thov nyiaj teev tseg, thiab
- koj muaj cai nyob raws li neeg tebchaws (residence requirements), thiab
- koj yuavtsum ua rawsli tus kevcai thov nyiaj (participation requirements) yog peb pom tias koj tsim nyog yuav tsum tau ua.

## Txojkev them nyiaj tu menyuam Parenting Payment

Cov nyiaj Parenting Payment ntawm koj yuav tau txais yog ntsuas rawsli koj tsev neeg saib nyob-noj zoo li cas (family situation). Nyob rau txhua lub xyoo thaum hnuv tim 20 lub Peb hlis thiab tim 20 lub Cuaj hlis nws yuav muaj kev txhim kho tshiab rau cov nyiaj pab no. ## Kev ntsuas nyiaj khwv tau thiab khoom muaj nqi ntawm txoj kev thov nyiaj Parenting Payment

Cov nyiaj Parenting Payment uas koj yuav tau txais yog ntsuas los ntawm saib neb ob niam txiv (yog tias koj muaj txiv/pojniam) khwv tau nyiaj ntau licas thiab muaj khoom muaj nqi ntau licas .

Cov khoom muaj nqi (assets), yog hais txog koj tej khoom muaj nqi uas yog koj tug los yog cov uas sib koom nrog lwm tus, sam tag nrho cov nyob lwm tebchaws thiab tej nyiaj-txiag uas koj tau muab qiv rau lwm tus.

Nyob rau txhua xyoo hnuv tim 20 lub Peb hlis j, hnuv tim 1 lub Xya hli thiab hnuv tim 20 lub 9 hlis ntuj yuav muaj kev txheeb-xyuas tshiab txog koj cov nyiaj khwv tau thiab cov khoom muaj nqi.

# Parenting Payment

Parenting Payment is income support for parents or guardians to help with the cost of raising children.

## Eligibility for Parenting Payment

Parenting Payment is paid to the principal carer of a child. Only one parent or guardian can receive the payment. You may qualify for Parenting Payment as a parent, grandparent, or foster carer, if:

- you are single and care for at least one child aged less than eight, or
- you have a partner and care for at least one child aged less than six, and
- the income and assets of both you and your partner (if you have one) are below certain amounts, and
- you meet residence requirements, and
- you are able to meet participation requirements if needed.

## Payment rates for Parenting Payment

The amount of Parenting Payment you get depends on your family situation. The rates are updated on 20 March and 20 September each year. For the latest rates visit [humanservices.gov.au/parentingpayment](https://humanservices.gov.au/parentingpayment)

## Income and assets tests for Parenting Payment

The amount of Parenting Payment you get depends on the income and assets of both you and your partner (if you have one).

An asset is any property or possession you own either partly or wholly. It includes assets held outside Australia and debts owing to you.
