When to use this form

Use this form to apply for **initial** PBS-subsidised brentuximab vedotin for patients with CD30 positive cutaneous T-cell lymphoma.

Important information

Initial applications to start PBS-subsidised treatment can be made in real time using the **Online PBS Authorities** system or in writing and must include sufficient information to determine the patient's eligibility according to the PBS criteria.

Under no circumstances will phone approvals be granted for **initial** authority applications.

The information in this form is correct at the time of publishing and may be subject to change.

Continuing treatment

This form is ONLY for **initial** treatment.

After an authority application for initial treatment has been approved, applications for **continuing** treatment with brentuximab vedotin can be made in real time using the **Online PBS Authorities** system, or by phone. Call 1800 700 270 Monday to Friday, 8 am to 5 pm, local time.

Call charges may apply.

Section 100 arrangements for brentuximab vedotin

This item is available to a patient who is attending:

- an approved private hospital
- a public participating hospital, **or**
- a public hospital

and is:

- a day admitted patient
- a non-admitted patient, **or**
- a patient on discharge.

This item is not available as a PBS benefit for in-patients of a public hospital.

Treatment specifics

The patient cannot receive more than 4 cycles of treatment under the **initial** treatment phase and 12 cycles of treatment under the **continuing** treatment phase.

Treatment must not exceed a total of 16 cycles in a lifetime.
