Definition of a partner

If you have a partner, we generally consider you a member of a couple. Under social security and family assistance law, we consider you a member of a couple if you are either:

- married
- in a registered relationship
- in a de facto relationship.

We may still consider you a member of a couple if you are not physically living with your partner. For example, your partner may fly-in fly-out or live away for work, like military or oil rig workers.

Changes you must tell us about

Tell us as soon as you can, if any of the following events occur. If you do not tell us, you may be overpaid, and we will have to ask for a refund.

- If you start to receive free board and/or lodging.

- salary/wages/commission
- superannuation
- retiring allowance

- child support for children in your care
- gifts or allowances of a regular nature
- allocated pensions/annuities
- managed investments
- trusts
- income from a deceased estate
- life interest
- royalties
- sickness or accident insurance
- profit from a farm, real estate or business.

E. Assistance from other sources

- provision of clothing, medication or other necessities.
