

Paroxysmal nocturnal haemoglobinuria – eculizumab or ravulizumab – initial grandfather authority application

When to use this form

Use this form to apply for **initial grandfather** PBS-subsidised eculizumab or ravulizumab for patients with paroxysmal nocturnal haemoglobinuria (PNH) who had, prior to **1 March 2022**:

- received non-PBS-subsidised treatment with eculizumab or ravulizumab – maintenance phase
- received eculizumab through the Australian Government's Life Saving Drugs Program (LSDP) and are continuing on eculizumab.

Important information

Initial grandfather applications to start PBS-subsidised treatment must be in writing and must include sufficient information to determine the patient's eligibility according to the PBS criteria.

Under no circumstances will phone approvals be granted for paroxysmal nocturnal haemoglobinuria **initial grandfather** authority applications.

Complement 5 (C5) inhibitors are defined as eculizumab or ravulizumab.

The information in this form is correct at the time of publishing and may be subject to change.

Continuing treatment

This form is **ONLY** for **initial grandfather** treatment.

For continuing PBS-subsidised treatment, the patient must qualify under the **first continuing** or **subsequent continuing** treatment criteria.

Section 100 arrangements for eculizumab and ravulizumab

These items are available to a patient who is attending:

- an approved private hospital, **or**
- a public hospital

and is a:

- day admitted patient
- non-admitted patient, **or**
- patient on discharge.

These items are not available as a PBS benefit for in-patients of a public hospital.

16 Prior to commencing treatment with eculizumab or ravulizumab, the patient had:

experienced a thrombotic/embolic event which required anticoagulant therapy

or

been transfused with at least 4 units of red blood cells in the last 12 months

or

debilitating shortness of breath/chest pain resulting in limitation of normal activity (New York Heart Association Class III) and/or established diagnosis of pulmonary arterial hypertension, where causes other than PNH have been excluded

or

a history of renal insufficiency, demonstrated by an eGFR less than or equal to 60 mL/min/1.73m², where causes other than PNH have been excluded

or

recurrent episodes of severe pain requiring hospitalisation and/or narcotic analgesia where causes other than PNH have been excluded

or

chronic/recurrent anaemia, where causes other than haemolysis have been excluded, together with multiple haemoglobin measurements:

not exceeding 70 g/L in the absence of anaemia symptoms

or

not exceeding 100 g/L in addition to having anaemia symptoms.
