

## When to use this form



Use this form to ask Services Australia to end your child support assessment. You can only ask to end the assessment on a date that falls after we have received this completed form. We will stop calculating how much child support is required to support your child(ren).

If you or your current partner are entitled to the higher rate of Family Tax Benefit (FTB) Part A, ending your child support assessment may affect your payments. Call Centrelink on **136 150** to discuss how this will affect you.

You can still receive child support under a private arrangement or agreement. If your circumstances change, you can reapply to us to calculate and collect child support.

**Important:** In most cases, only a person who is entitled to receive child support for a child can apply to end their assessment. In some cases, either parent/non-parent carer can apply but only if you have a child support agreement that started your child support case and the agreement is currently suspended.

## Online account



You can access your Child Support online account through myGov. myGov is a secure way to access a range of government services online with one username and password. You can create a myGov account at **my.gov.au** and link your Child Support online account to it.
