Australian Government Disaster Recovery Payment (AGDRP) cu thanhmi kokek rawhnak nih fak piin an hnorsuan ahcun nangmah an bawmtu ding a si. Hihi cu tlawmte rawhnak asilole siaremlonak caah a si lo.

Zeizat dah na ngah khawh

Phung nih a onhmi na si ahcun, na ngah lai:

- \$1,000 upa pakhat ah
- kum 16 nak a no deuhmi ngakchia caah \$400.

Aho nih dah a ngah khawh

AGDRP ngah dingah:

- AGDRP umthutnak lei phungphai pawl na tlinh hrimhrim lai
- kokek rawhnak a chuah lio ah kum 16 asilole upadeuh asilole kum 16 tang le phung nih a onhmi tangka pekmi a ngahmi na si hrimhrim lai
- thanhmi hmunhma lei phung nih a onhmi sinak lei a herhmi pawl na tlinh hrimhrim lai.

A sullam fianternak pawl

- Khuasaknak nan hman bikmi hmun cu punghmaan in umnak nawl na ngeihmi asilole laisen na ngeihmi a biapibikmi hmun a si. Hi ah hin idin caan umnak inn pawl, tangka hrambunhnak lei thilri pawl, chungkhar asilole hawikom pawl he chikhat umnak, hrennak hmun pawl asilole thonginn aa tel lo.
- A biapimi thilri cu \$20,000 asilole tamdeuh man thilri pakhat asilole fonhmi thilri pawl a si. Tahchunhnak ah, hi ah hin inn pawl, mawtaw pawl, thilphornak mawtaw hnulei i thlahmi, ti chiahnak tengki asilole seh a nganmi pawl.
- A nikhatnak ni ah phung nih a onhmi ngakchia zohkhenhtu na si i thanhmi kokek rawhnak nih an hnorsuan ahcun hi pawl chungin pakhat kha nangmah caah hman a si:
 - mah ngakchia caah a biapibikmi zohkhenhtu dirhmun in Parenting Payment, JobSeeker Payment, Youth Allowance for job seekers asilole Special Benefit kha na ngah
 - kum 15 asilole a no deuhmi, mah ngakchia caah Family Tax Benefit na ngah, i ngakchia zohkhenhnak ah a tlawmbik 66% na ngei

- kum 15 asilole a no deuhmi ngakchia i nifatin zohkhenhnak, thatternak le thanchoternak caah phung ningin tuanvo na ngei.

Halnak kongkau ah bawmh na herh ahcun, **180 22 66** hi na chawnh khawh. Fon line cu mah umnak hmun caan in 8 am in 5 pm tiang Nikhatni in Ningani tiang on a si. Holhlettu na hal khawh i manlo in kan in tawlrel piak khawh.

Nuva i chungtel pakhat na si ahcun, hi pekmi a pahnih ningin na hal khawh. Nangmah le nupa sinak tuahtimi nih a dang tein nan hal hrimhrim lai.

Fianternak

Australian Government Disaster Recovery Payment

The Australian Government Disaster Recovery Payment (AGDRP) is a one-off payment to help you if you are significantly affected by a declared disaster. It is not for minor damage or inconvenience.

How much you can get

If you are eligible you will get:

- \$1,000 per adult
- \$400 for each child younger than 16.

Who can get it

To get AGDRP you must:

- meet AGDRP residence rules
- be 16 years or older at the time of the disaster or under 16 and getting an eligible payment
- meet declared area eligibility requirements.

You must have been adversely affected by a declared disaster. For example:

- you were seriously injured
- you are the immediate family member of an Australian citizen or resident who died or is missing
- the disaster destroyed your principal place of residence or it must be demolished
- there has been major damage to the interior of your principal place of residence
- the disaster has exposed the interior of your principal place of residence to the elements
- your principal place of residence has been declared structurally unsound
- sewage has contaminated the interior of your residence
- the disaster has destroyed or damaged a major asset or assets you own at your principal place of residence
- you are the carer of an eligible child who has experienced any of the above.

Definitions

- Your principal place of residence is the main place where you have a right or licence to normally live. It does not include holiday homes, investment properties, temporary stays with family or friends, detention facilities or prison.
- A major asset is an asset or assets with a combined market value of \$20,000 or more. For example, this includes buildings, vehicles, caravans, water tanks or large scale machinery.
- You were the carer of an eligible child on the first day you were affected by the declared disaster, and one of these points apply:
 - you get Parenting Payment, JobSeeker Payment, Youth Allowance for job seekers or Special Benefit as a principal carer of that child
 - you get Family Tax Benefit for that child, the child is 15 or younger and you have at least 66% care of the child
 - you have legal responsibility for the day-to-day care, welfare and development of the child who is 15 or younger.

How to claim

The fastest way to claim is online. You will need to set up a myGov account and link to Centrelink if you do not have one yet. Go to servicessaustralia.gov.au/mygovguides

If you need help with claiming, you can call **180 22 66**. The phone line is open Monday to Friday from 8 am to 5 pm local time. You can ask for an interpreter and we will arrange one for free.

If you are a member of a couple, you can both claim this payment. You and your partner must make separate claims.
