When to use this form

Use this form to apply for **initial** PBS-subsidised monotherapy with pulmonary arterial hypertension (PAH) agents.

PAH agents refer to ambrisentan, bosentan, epoprostenol, iloprost, macitentan, riociguat, sildenafil and tadalafil.

Important information

Initial applications to start PBS-subsidised treatment can be made in real time using the **Online PBS Authorities** system or in writing and must include sufficient information to determine the patient's eligibility according to the PBS criteria.

Under no circumstances will phone approvals be granted for pulmonary arterial hypertension **initial** authority applications.

Change and continuing treatment

This form is **ONLY** for **initial** treatment.

After an authority application for **initial** treatment has been approved, applications to **change** or **continue** treatment with PAH agents can be made in real time using the **Online PBS Authorities** system, or by phone. Call 1800 700 270 Monday to Friday, 8 am to 5 pm, local time.

Dual therapy or triple therapy treatment

After a written authority application for **initial** monotherapy treatment has been approved, dual therapy or triple therapy treatment may be approved if standard monotherapy treatment options are not suitable, or have failed.

Applications for dual therapy or triple therapy can be made in real time using the **Online PBS Authorities** system, or by phone. Call 1800 700 270 Monday to Friday, 8 am to 5 pm, local time.
