Child Care Subsidy i save helpim long baim ol samting bilong lukautim pikinini. Sapos yu inap long kisim dispela mani, mipela bai givim dispela mani long ol lain i save lukautim pikinini bilong yu long daunim fi yu i save peim.

Yu mas mitim ol dispela lo bilong yu ken kisim dispela helpim:

- lukautim wanpela pikinini i gat 13-pela krismas o aninit moa na i no stap long sekenderi skul, sapos i no gat narapela lo i makim olsem i no gat wok long lukautim pikinini
- · yusim wanpela sevis bilong lukautim ol pikinini
- · yu yet bai peim ol fi bilong lukautim pikinini
- mitim ol residensi na ol rot bilong kisim marasin bilong lukautim ol.

Namba bilong hamas Child Care Subsidy yu ken kisim em i bihainim ol dispela samting i stap aninit:

- mani bilong famili bilong yu
- namba bilong ol pikinini yu lukautim
- mak bilong pe long wanpela aua, em i makim wanem kain ples yu save lukautim pikinini long en na krismas bilong pikinini bilong yu
- Famili bilong yu i gat wanem kain sindaun, na hamas aua yu na patna bilong yu i save mekim ol samting em gavman i orait long en.

Mani bilong famili

Mipela bai yusim mani bilong famili bilong yu long kauntim hamas mani yu inap kisim long Child Care Subsidy. Yu mas kamap wantaim wanpela estimet bilong hamas mani yu save kisim long wan wan yia, na bai mipela i ken kauntim hamas mani bilong Child Care Subsidy yu mas peim bilong sevis bilong lukautim pikinini bilong yu.

Hamas mani bai yu kisim long Child Care Subsidy i ken senis sapos pe bilong yu i senis. Bilong save yu kisim stret mani bilong Child Care Subsidy, yu mas sekim na stretim ol pe yu save kisim.

Balens

Long pinis bilong yia, mipela bai balensim ol peimen bilong yu. Mipela bai mekim dispela long skelim hamas mani yu putim i go daun long wan wan yia na hamas mani stret yu save kisim long wan wan yia. Dispela bai helpim yu long save olsem yu kisim stret mani bilong dispela sabsidi.

Sapos mani yu ting yu bai kisim i no bikpela tumas long pe yu save kisim, orait yu mas bekim dispela mani. Mipela bai yusim mani mipela i bin pasim long Child Care Subsidy bilong daunim mani yu mas bekim.

Namba bilong ol pikinini ol i lukautim

Sapos yu gat planti pikinini i gat 5-pela krismas na i go daun, yu ken kisim bikpela mani bilong Child Care Subsidy bilong wanpela o sampela pikinini bilong yu.

Sapos yu inap long kisim dispela helpim:

- nambawan pikinini bilong yu i gat 5-pela krismas o aninit bai kisim wankain mani bilong Child Care Subsidy, em ol i save skelim long pe bilong en,
- ol liklik pikinini inap kisim bikpela pe bilong Child Care Subsidy.

Namba bilong mani yu inap kisim long pikinini bilong yu em 95%. Ol pikinini i gat 6-pela krismas na i go antap ol bai kisim pe bilong Child Care Subsidy.

Bikpela Child Care Subsidy em ol i no save bihainim long ol hap long In Home Care (Lukautim pikinini long haus).

Additional Child Care Subsidy

Additional Child Care Subsidy i save givim ol famili sampela moa help wantaim ol fi bilong lukautim pikinini. Yu mas kisim Child Care Subsidy long yu ken kisim Additional Child Care Subsidy. I gat ol kainkain i stap we yu i ken aplai long kisim:

- Additional Child Care Subsidy (Grandparent). Dispela bai helpim yu long baim ol samting bilong lukautim pikinini sapos yu wanpela bubu o wanpela tumbuna papa o wanpela tumbuna mama i lukautim bubu pikinini bilong yu o wanpela tumbuna pikinini bilong yu. Bilong yu ken kisim dispela helpim, yu mas kisim pe bilong helpim yu long kisim mani.
- Additional Child Care Subsidy (Temporary Financial Hardship). Dispela bai helpim yu long sotpela taim tasol long baim ol samting bilong lukautim pikinini sapos yu gat hevi long mani long sampela taim, long wanem, yu no gat strong long stretim dispela hevi.
- Additional Child Care Subsidy (Transition to Work). Dispela bai helpim yu long baim ol samting bilong lukautim pikinini sapos yu lusim wok mani bilong yu na yu mekim wok mani, stadi o ol trening aktiviti.

I gat Additional Child Care Subsidy (Child Wellbeing) we yu i ken askim ol sevis bilong lukautim ol pikinini. Dispela bai helpim ol famili na ol pikinini we ol i no gat strong o ol i no gat planti samting. Lain we i save lukautim pikinini bilong yu i mas raitim dispela pepa long nem bilong yu.

Child Care Subsidy

Child Care Subsidy helps with the cost of approved child care. If you are eligible, we will pay it directly to your child care provider to reduce the fees you pay.

To be eligible you must meet all of the following:

- care for a child 13 years of age or younger who is not in secondary school, unless an exemption applies
- · use an approved child care service
- be responsible for paying the child care fees
- meet residency and immunisation requirements.

To meet the residency requirements, you or your partner must be living in Australia and have one of the following:

- Australian citizenship
- a permanent residence visa
- · a Special Category visa
- a certain temporary visa type, for example, a Partner Provisional or Temporary Protection visa.

You may also meet the residency requirements if any of the below apply:

- you or your partner are an overseas student, sponsored by the Australian Government to study in Australia
- · you are in hardship or special circumstances apply.

You may be exempt from some of these criteria in specific circumstances.

How much Child Care Subsidy you can get

The amount of Child Care Subsidy you can get depends on all of the below:

- · your family's income
- · the number of children in your care
- the hourly rate cap based on the type of approved child care you use and the age of your child
- your family's circumstances and the hours of recognised activities you and your partner do.

Family income

We will use your family income to work out the amount of Child Care Subsidy you can get. You will need to provide an income estimate each financial year so we can calculate how much Child Care Subsidy to pay your child care service.

The amount of Child Care Subsidy you can get may change if your income changes. To make sure you get the right amount of Child Care Subsidy you need to check and update your income estimate.

Withholding

To help reduce the chance of an overpayment, we will withhold 5% of your Child Care Subsidy each fortnight. You can change the amount we withhold.

Balancing

At the end of the financial year we balance your payments. We do this by comparing your income estimate to your actual income. This will make sure you got the correct amount of subsidy.

If your income estimate is lower than your actual income you may have an overpayment which you will need to pay back. We will use the Child Care Subsidy we withheld to reduce the amount you have to pay back.

If your income estimate is higher than your actual income and you did not get enough Child Care Subsidy, we will pay any outstanding amount directly to you. This will include the Child Care Subsidy we withheld.

Number of children in care

If you have more than one child aged 5 or under in care, you may get a higher rate of Child Care Subsidy for one or more of your children.

If you are eligible:

- your eldest child aged 5 or under will get your standard income tested Child Care Subsidy rate,
- any younger children may get a higher rate of Child Care Subsidy.

The most you can get for your higher rate child is 95%. Any children aged 6 and above will continue to get your standard Child Care Subsidy percentage.

The higher Child Care Subsidy rate does not apply to In Home Care sessions of care.

Hourly rate cap

The amount of Child Care Subsidy you can get will depend on the type of approved child care you use and the age of your child.

Your Child Care Subsidy percentage will apply to either the hourly fee you are charged by your child care service or the hourly rate cap, whichever is lower.

Activity Test

The hours of subsidised child care you can get each fortnight depends on your circumstances and the hours of recognised activities you do. We call this an activity test.

Recognised activities can include:

- paid work including leave, like maternity leave
- · study and training
- unpaid work in family business

- looking for work
- volunteering
- self-employment
- · other activities on a case-by-case basis.

If you have a partner, we will look at both of your activity levels. We will use the lower of your or your partner's activity level to work out your hours of subsidised child care.

To make sure you get the right amount of Child Care Subsidy you need to check and update your activity test if your or your partner's circumstances change.

How to claim Child Care Subsidy

To make a claim online you need a myGov account and a Centrelink online account. Your myGov account must be linked to Centrelink.

If you do not have a myGov account, go to my.gov.au to create one.

Use your Centrelink online account in myGov to claim Child Care Subsidy, provide your information and any supporting documents.

Additional Child Care Subsidy

Additional Child Care Subsidy offers some families extra help with their child care fees. You must be eligible for Child Care Subsidy to be eligible for Additional Child Care Subsidy. There are different types you can apply for:

- Additional Child Care Subsidy (Grandparent). This helps with the cost of child care if you are a
 grandparent or great grandparent with primary care of your grandchild or great grandchild. To
 be eligible, you must get an income support payment.
- Additional Child Care Subsidy (Temporary Financial Hardship). This gives short-term help with the cost of child care if you are in temporary financial hardship due to circumstances beyond your control.
- Additional Child Care Subsidy (Transition to Work). This helps with the cost of child care if you
 are transitioning from an income support payment by engaging in work, study or training
 activities.

There is also Additional Child Care Subsidy (Child Wellbeing) which you can ask your child care service about. This helps vulnerable or disadvantaged families and children. Your child care provider will need to apply on your behalf.

How to apply for Additional Child Care Subsidy

To apply online you need a myGov account and a Centrelink online account. Your myGov account must be linked to Centrelink.

Use your Centrelink online account through myGov to provide your information and any supporting documents.
