

## Midwife Professional Indemnity Run-Off Cover Scheme Deceased midwife (M0040)

### When to use this form

The statutory declaration attached to this form must be completed by the legal personal representative of a deceased person who had been an eligible midwife.

This is to support eligibility under the Midwife Professional Indemnity Run-Off Cover Scheme (MPIROCS) when a valid death certificate is not available.

**Note 1** Chapter 2 of the Criminal Code applies to all offences against the *Statutory Declarations Act 1959* — see section 5A of the *Statutory Declarations Act 1959*.

**A statutory declaration under section 9 of the  
Statutory Declarations Act 1959 may be made before –**

- (1) a person who is currently licensed or registered under a law to practice in one of the following occupations:
  - Architect
  - Chiropractor
  - Dentist
  - Financial adviser
  - Financial Planner
  - Legal practitioner
  - Medical practitioner
  - Midwife
  - Migration agent registered under Division 3 of Part 3 of the *Migration Act 1958*
  - Nurse
  - Occupational therapist
  - Optometrist
  - Patent attorney
  - Pharmacist
  - Physiotherapist
  - Psychologist
  - Trade marks attorney
  - Veterinary surgeon
- (2) a person who is enrolled on the roll of the Supreme Court of a state or territory, or the High Court of Australia, as a legal practitioner (however described); or
- (3) a person who is in the following list:
  - Accountant who is:
    - (a) a fellow of the National Tax Accountants' Association; or
    - (b) a member of any of the following:
      - i. Chartered Accountants Australia and New Zealand;
      - ii. the Association of Taxation and Management Accountants;
      - iii. CPA Australia;
      - iv. the Institute of Public Accountants
  - Agent of the Australian Postal Corporation who is in charge of an office supplying postal services to the public
  - APS employee engaged on an ongoing basis with 5 or more years of continuous service who is not specified in another item in this list
  - Australian Consular Officer or Australian Diplomatic Officer (within the meaning of the *Consular Fees Act 1955*)
  - Bailiff
  - Bank officer with 5 or more continuous years of service
  - Building society officer with 5 or more years of continuous service

    - (a) at a place outside Australia; and
    - (b) authorised under paragraph 3(c) of the *Consular Fees Act 1955*; and
    - (c) exercising the employee's function at that place
  - Engineer who is:
    - (a) a member of Engineers Australia, other than at the grade of student; or
    - (b) a Registered Professional Engineer of Professionals Australia; or
    - (c) registered as an engineer under a law of the Commonwealth, a state or territory; or
    - (d) registered on the National Engineering Register by Engineers Australia
  - Finance company officer with 5 or more years of continuous service

  - Permanent employee of the Australian Postal Corporation with 5 or more years of continuous service who is employed in an office providing postal services to the public

    - (a) a state or territory or a state or territory authority
    - (b) a local government authoritywith 5 or more years of continuous service, other than such an employee who is specified in another item of this list
  - Person before whom a statutory declaration may be made under the law of the State or Territory in which the declaration is made
