When to use this form

Use this form if you (or a dependent child(ren) under 14 years of age) have an Individual Healthcare Identifier (IHI) and want to:

- request a pseudonym IHI for yourself (or your dependent child(ren)), or
- merge a pseudonym IHI with your (or your dependent child(ren)'s) actual IHI.

Individuals 14 years of age and over can request their own pseudonym IHI using this form.

Pseudonym healthcare identifier

You may only have one pseudonym record created for yourself (or your dependent child(ren)) at any one time.

You may not claim Medicare or pharmaceutical benefits for receipts in a pseudonym name.

No other programmes or entitlements administered by Services Australia may be added to the pseudonym record being created.

My Health Record

A My Health Record is an online summary of an individual's health information. It can be accessed at any time by the individual and their healthcare providers. You can get a My Health Record with a pseudonym IHI. This is not linked to your existing My Health Record (if you have one).

Evidence of identity

You must provide **1** certified document from the Primary group or **2** certified documents from the Secondary group for each person applying for a pseudonym IHI. The names in these documents must be identical.

Documents provided must be current at time of application.

We cannot process your application if your document(s) are not certified. For information about how to certify documents, go to servicesaustralia.gov.au/hi

Primary group

- Australian passport
- Medicare card
- foreign passport or travel document with valid Australian visa
- Australian driver licence
- photo identification card issued by the Commonwealth, state or territory government
- Australian birth certificate or birth extract
- Australian proof of age card

Secondary group

- Department of Foreign Affairs and Trade (DFAT) issued United Nations convention travel document
- foreign government issued documents (for example, driver licences)
- security guard/crowd control photo licence
- consular photo identity card issued by DFAT
- Australian tertiary student photo identity document
- Australian secondary student photo identity document
- certified academic transcript from an Australian university
- bank or credit card
