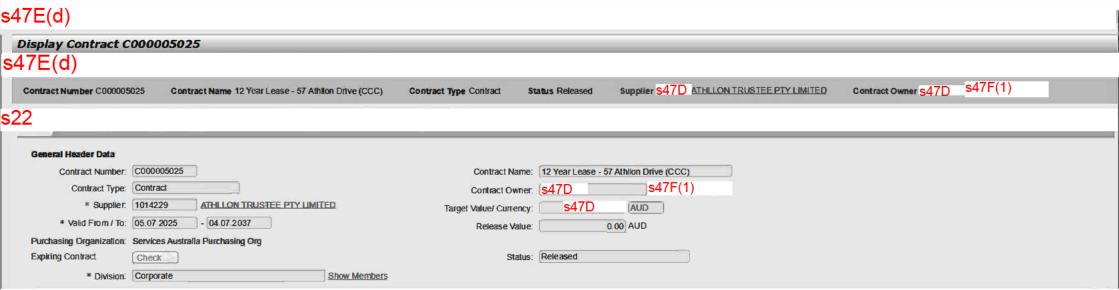

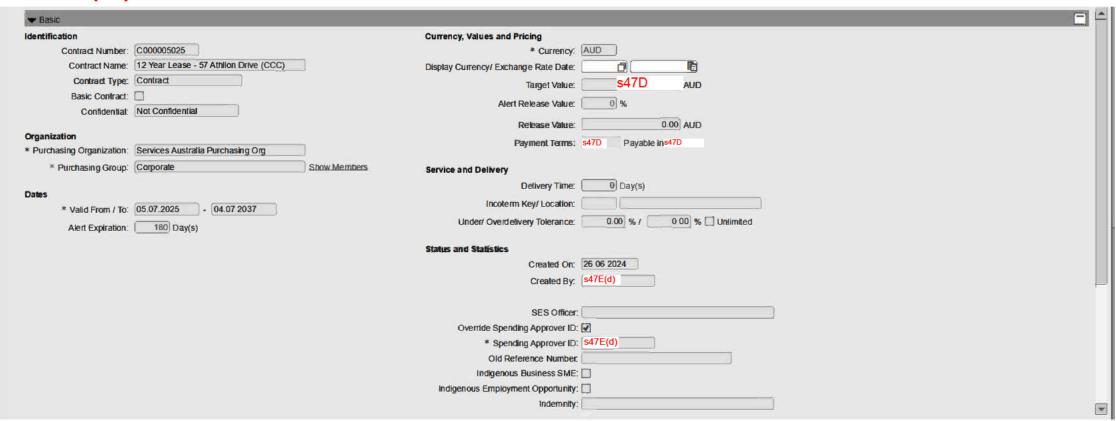

Recommendations

It is recommended that the Committee:

- 1. **endorse** the execution of the Heads of Agreement for a new 12 year lease at the Caroline Chisholm Centre with the nominal expiration date of July 2037.
- 2. **endorse** that Services Australia continue to consolidate our footprint into 2 buildings within Tuggeranong, Caroline Chisholm Centre and Louisa Lawson Building.

Key risks and issues

Tuggeranong strategy

- 1. In August 2022 and February 2023, the Committee endorsed a variety of options for the commencement and continuation of the planning and design stages for Tuggeranong.
- 2. Since that time, the Corporate and Cross Government Services Division (the Division) has facilitated a series of consultative workshops targeting Groups/Divisions/Branches in the Tuggeranong geographical area. These workshops focused around understanding the functional property requirements to shape and identify the true spatial requirements for the agency's workforce.
- 3. Additionally, the Committee also endorsed a series of principles that will shape our future accommodation offering:
 - no individual ownership of desks
 - flexible desk allocations to business areas
 - ratio allocation of desks to staff
 - co-located business areas.
- 4. Based on the overarching functional requirements gleaned from the workshops, the Committee endorsed accommodation principles and our workforce numbers within Tuggeranong. The Division identified that Services Australia (the agency) can move forward with a Tuggeranong strategy. This would only require us to hold 2 buildings, those being Caroline Chisholm Centre (CCC) and Louisa Lawson Building.

- 6. This approach negates the need to facilitate the construction of a bespoke Information and Communications Technology hub within Tuggeranong as we have the space, capacity and incentive funding to achieve a 2 building solution through positive lease negotiations with the CCC landlord.
- 7. In reducing to 2 buildings within Tuggeranong, the agency achieves the following benefits:
 - a reduction in sqm across the Tuggeranong area from 98,650sqm to 66,306sqm
 - s47D
 - provides maximum capital incentive funding for a staged refit of CCC
 - a reduction in our carbon footprint and a move towards properties that are sustainable and able to scale and respond to surge
 - updated workspaces that are flexible and able to be adapted to support diverse types of work and ways of working
 - provides a people-centric and technology enabled work environment attracting talent that requires contemporary, human-centred design, clever use of technology and incorporating wellbeing indices into our workplaces.
- 8. The Division is in the process of finalising a detailed master report that will provide specific engineering details on how and where each critical function will be located within Tuggeranong under this scenario.

- 10. The key points of the terms and conditions are as follows:
 - 12 year extension, expiring 4 July 2037, with a 5 year option
 - annual rent of \$^{s47D} per sgm (reduced from current rate of \$^{s47D})
 - \$\$47D per car parking bay totalling \$47D per year (costs currently included in the rent)
 - 3.25% annual increases.

13. The negotiations have been ongoing since September 2021, <u>Attachment A</u> demonstrates how the offer has increased in value for the agency.

Background

- 14. On 10 August 2022, the Division outlined the proposed property strategy for Tuggeranong. The Committee endorsed proceeding with negotiations with the CCC landlord with the objective to maximise the capital incentive to enable the building to be refurbished and provide the opportunity to cease other buildings in the immediate area (EC22-002062 refers).
- 15. On 9 February 2023, the Division provided an update to the property strategy for Tuggeranong. The Committee agreed for the continuation of the planning and design stages of Tuggeranong that included incorporation of agile based work and density overlays (EC22-004645 refers).

Strategic alignment

16. This proposal is consistent with the Property Strategy and the Corporate Plan 2022–2023.

Stakeholder perspectives

17. Stakeholders did not raise any significant concerns during the consultation process.

Financial considerations

18. The Division will manage the continuation of planning and requirements gathering with stakeholders within existing budgets.

Whole-of-government considerations

19. The Commonwealth Property Management Framework, Australian Public Service (APS) Workforce Strategy, and the APS Location Strategy will influence the direction of the planning phases.

Next steps

- 20. Pending agreement, the Division will progress with executing the Heads of Agreement and proceed to finalise the lease extension through the lease endorsement process with the Department of Finance.
- 21. The Division will progress with the detailed planning for the capital works program for CCC, with the intent to have a staged floor-by-floor approach. A high-level program is at Attachment B, however it will continue to be refined over the course of the next few months.

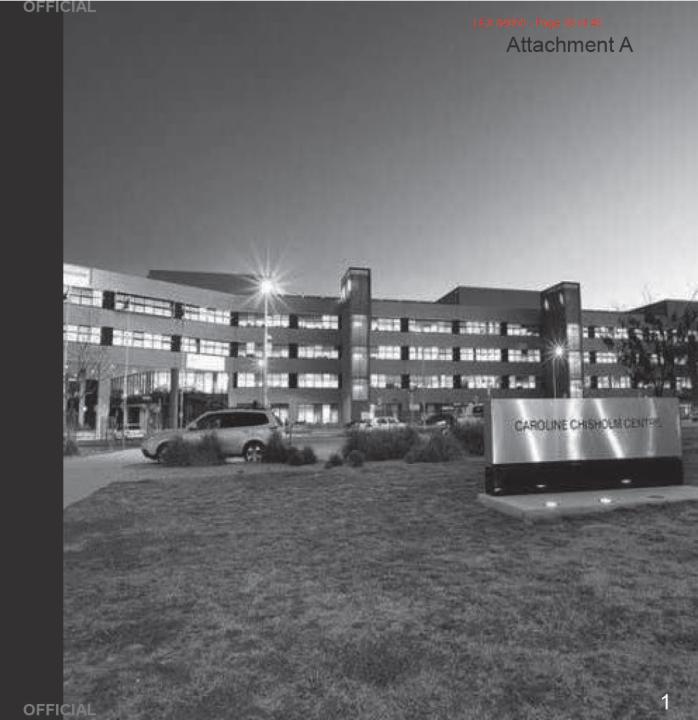

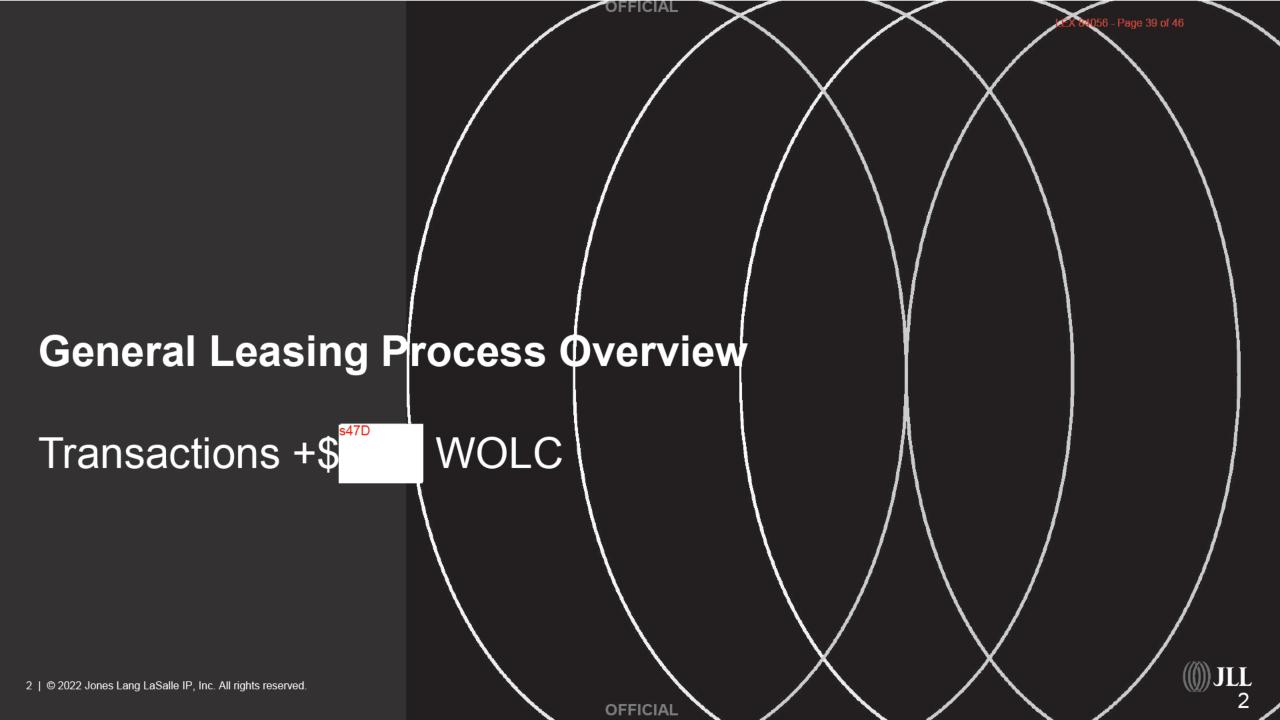

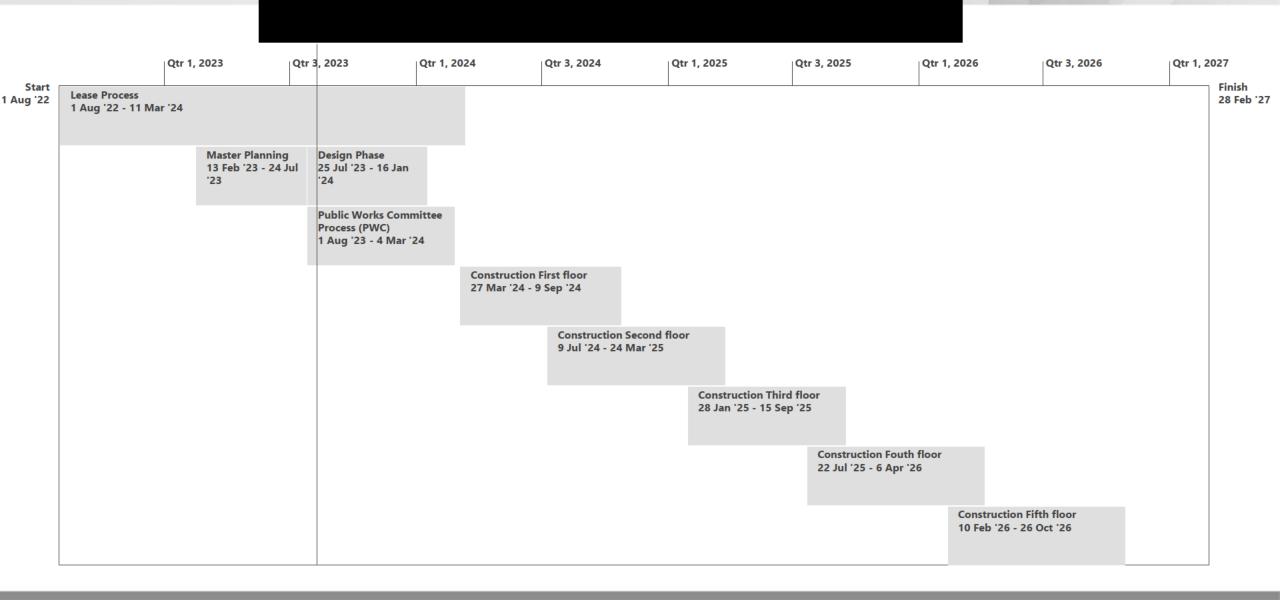
