Tani waxay naga caawinaysaa inaan xogtaada kuu xafidno.



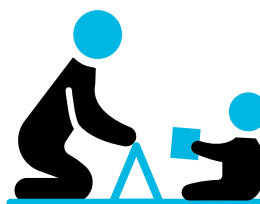
Lacagaha iyo kaalmada aad naga heli karto waxay ku xiran tahay xaaladdaada.

Family Tax Benefit waa lacag lagu caawiyo waalidiinta si ay ugu daryeelaan caruurtooda.

Waxaan siinaa hal waalid si uu u caawiyo qoyska oo dhan.



Haddii ilmahaagu aado xannaanada carruurta markaad shaqaynayso ama aad wax baranayso, Child Care Subsidy (Kaalmada Daryeelka Ilmaha) ayaa kaa caawin karta inay yareyso kharashka lagu daryeelayo ilmahaaga.



Rent Assistance (Kaalmada kirada) waa lacag dheeraad ah oo joogto ah oo aad heli karto haddii aad kiro dhiibto oo aadna naga hesho lacag caydh ah anaga.

Haddii aad gmeesha aad degan tahay ka guurto ama lacagta kirada ee aad bixiso ay isbedesho, waa inaad noo sheegtaa.



Haddii aad shaqeyso ama aad hesho lacag kale, waa inaad noogu soo sheegtaa 14 maalmood gudahood.

Sababta sidaas loo sameynayo ayaa waxay tahay si aan kuu siino inta aad xaq u leedahay ee lacag ah.



Waxaad soo kaxaysan kartaa qof aad ku kalsoon tahay si uu kuu caawiyo markaad nala soo xiriirayso. Qofkaas waxaan ugu yeernaa nominee (qof aad u magacaabatay inay kuu hadlaan).

Way nala hadli karaan, waxay nala wadaagi karaan macluumaad ama xataa lacagta ayay kuu qaadi karaan.

Nala soo socodsii haddii aad rabto inaad taas joojiso wakhti kasta.



Social workers (shaqaalaha bulshada) waxay caawin karaan dadka marka ay dhibaato la kulmaan. Waxaad u sheegi kartaa waxyaabaha aad ka welwelsan tahay ama dhibaatooyinka ku heysta.

Way ku dhegeysan doonaan, waxay kula wadaagi doonaan macluumaad waxayna sidoo kale kuu sheegi doonaan wixii kaloo caawimaad ah ee aad heli karto.

How we can help you



When you speak to us, we ask you questions to make sure it is you and not someone pretending to be you.

This helps us to keep your details safe.



The payments and help you can get from us depends on your situation.

Talk to our staff if you need help, information or if something changes.



Family Tax Benefit is money to help parents take care of their children.

We pay it to one parent to help the whole family.



If your child goes to child care while you work or study, Child Care Subsidy can help lower your child care costs.



Rent Assistance is an extra regular amount you may get if you pay rent and get an eligible payment from us.

If you move or your rent amount changes, you must tell us.



If you work or get other money, you must tell us within 14 days.

This is so we can pay you the right amount.



You can have someone you trust to help you deal with us. We call them a nominee.

They can talk to us, give us information or get payments for you.

Let us know if you want to stop this at any time.



Social workers can help people when they have problems. You can tell them about things that make you feel worried or distressed.

They will listen, give you information and tell you about other help.
