



Habari kutoka Services Australia kwa wazazi wa wanafunzi wapya

Ikiwa mtoto wako anamaliza shule ya juu na anaendelea na masomo ya juu zaidi, anaweza kustahili malipo ya mwanafunzi kutoka Centrelink.

Malipo ya wanafunzi, kama Youth Allowance, yanapatikana kwa wanafunzi wanaosoma katika chuo kikuu au TAFE, au wanaofunzwa kama Mwanagenzi (Apprentice) wa Australia. Ni malipo ya wiki mbili ambayo husaidia kwa gharama za kusoma.

Mtoto wako unaweza kupata Youth Allowance kutoka Centrelink ikiwa anastahiki na kukidhi mahitaji ya makazi. Anahitaji:

- kuwa na umri chini ya miaka 25
- kusoma wakati wote, na
- kusoma kozi iliyoidhinishwa katika taasisi iliyoidhinishwa.

Kiasi ambacho mtoto wako anaweza kupata kinategemea na hali zao.

Ikiwa mtoto wako ana umri wa chini ya miaka 22, kwa kawaida tunawachukulia kuwa ni mtegemezi. Katika kesi hii, tunahitaji maelezo yako ya mapato ili kuangalia kama mtoto wako anastahili malipo.

Ikiwa unapata Family Tax Benefit kwa mtoto wako, hii kawaida huisha anapoondoka shule ya sekondari. Ikiwa ataendelea kusoma, anapaswa kuomba Youth Allowance yeye mwenyewe. Anaweza kuomba hadi wiki 13 kabla ya tarehe ya kuanza kwa kozi yake, au Australian Apprenticeship (Uanagenzi).

Unaweza kuhakiki mtandaoni ikiwa mtoto wako unaweza kupata Youth Allowance au malipo mengine ya wanafunzi. Nenda kwa servicesaustralia.gov.au/students

Information from Services Australia for parents of new students

If your child is leaving high school and going on to further study, they may be eligible for a student payment from Centrelink.

Student payments, like Youth Allowance, are available for students studying at university or TAFE, or those training as an Australian Apprentice. They are fortnightly payments that help with the costs of studying.

Your child may get Youth Allowance from Centrelink if they are eligible and meet residence requirements. They need to be:

- aged under 25
- studying full time, and
- studying an approved course at an approved institution.

How much your child can get depends on their circumstances.

If your child is aged under 22, we usually consider them dependent. In this case, we need your income details to check your child is eligible for a payment.

If you get Family Tax Benefit for your child, this usually ends when they leave high school. If they keep studying they should apply for Youth Allowance themselves. They can apply up to 13 weeks before the start date of their course, or Australian Apprenticeship.
