Ako ispunjavate zdravstvene i nezdravstvene uvjete, možda imate pravo na Disability Support Pension od Services Australia.

Više o uvjetima i načinu na koji se procjenjuje vaš zahtjev možete pročitati na internetskim stranicama Services Australia.

Također možete koristiti naš internetski vodič Disability Support Pension pre-claim guide koji vam može pomoći pri odluci želite li podnijeti zahtjev, ali vam ne može reći možete li dobiti tu vrstu plaćanja.

Ako mislite da je to odgovarajuća vrsta plaćanja za vas, morate dostaviti medicinske dokaze koji potkrepljuju vaš zahtjev.

Također biste trebali pročitati naše informacije Program of Support u slučaju da se to odnosi na vas. Ovaj program pomaže osobama s invaliditetom da se pripreme, pronađu i zadrže posao.

Kada budete spremni podnijeti zahtjev, najlakši i najbrži način podnošenja zahtjeva je putem interneta.

Ako već imate Centrelinkov referentni broj (CRN), možete podnijeti zahtjev putem interneta putem svog myGov računa.

Ako nemate CRN, možete ga dobiti na my.gov.au.

Ne trebate ići u uslužni centar.

Ako ste imenovali svoga zastupnika za korespondenciju, ta osoba može podnijeti zahtjev u vaše ime putem interneta. Ako nemate zastupnika a želite ga imati, to morate sami uspostaviti.

Invalidsku mirovinu ne može dobiti svaka osoba s invaliditetom ili trajno poremećenim zdravstvenim stanjem. Ako ne možete dobiti ovu mirovinu, možda ćete moći dobiti druga plaćanja od Services Australia.

Services Australia Disability Support Pension

Do you have a permanent medical condition that stops you from working?

You may be able to get Disability Support Pension from Services Australia if you meet both non-medical and medical rules.

You can read more about what these rules are and how we assess your claim on the Services Australia website.

You can also use our online Disability Support Pension pre-claim guide. It will not tell you if you can get the payment but it will help you decide whether to claim.

If you think it is the right payment for you, make sure you have medical evidence to support your claim.

You should also read our information on Program of Support in case that applies to you. This program helps people with disability to prepare for, find and keep a job.

When you are ready to submit a claim, the easiest and quickest way to claim is online. If you already have a Centrelink Customer Reference Number (CRN), you can claim online through your myGov account.

If you do not have a CRN, go to **my.gov.au** to get one.

You do not need to visit a service centre.

If you have a correspondence nominee they can claim for you online. If you do not have a correspondence nominee and you want one, you need to set this up.

Not everyone with disability or a medical condition can get Disability Support Pension. If you cannot get it you may be able to get other payments from Services Australia.
