



Family Tax Benefit

Nhe balang marrang Family Tax Benefit (FTB) ngunhiyi balang nhe:

- yothu yutamirr
- young djamrrkulimirr nhokal carengur
- ngayatham ga djamarrkuliny ngunhiyi high schoolngur wu approved studyngur ngunhiyi yaka ga marram Centrelink.

Buluny balang nhe marrang FTB ngunhiyi nhe ga djaka yothuw wu djamarrkuliw ngunhiyi yaka nhungu. Dhuwandja mak balang yothu wu djamarrkuli gurrutumirriwung nhokung ngunhiyi lika nhokal nhina wu nhe mak kinship carer.

Ngunhiyi nhakun nhe dhu dhawalguyangan yothuny, nhe balang wiripung nguruyirryurr nhungu FTB claim 3 ngalindi yornnha dhu yothu dhawalaguyangan. Dhuwandja yaku pre-birth FTB claim.

Balanyamirri claiming dhu FTB'ny nhe dhu gurrupan limmurrungal:

- nhungu Tax File Number (TFN) ga ngunhiyi nhe partnermirr, nhanngu TFN
- nhungu Customer Reference Number (CRN)
- djorra mala ngunhiyi dhuka milkum nhe nhunhiyi carer yothuw wu djamarrkuliw ngunhiyi nhe ga claiming.

Ngunhiyi nhe TFN miriw, nhe balang apply balanyaraw visitdhu limurrung local service center wu wanganharay Service Australia (Centrelink) wal balanyamirriy walal dhu doyyun nhokal communityngur.

Ngunhiyi nhe nguruyirryurra nhungu pre-birth FTB claimdja, needdja limurr djorra ngunhiyi dhu watjpilyu gurrupan dhangura yothun dhu yutan dhawalguyangan. Need limurr dhiyakuny djorraw marrka dhu dhawarmaraman nhungu pre-birth FTB claim ga buluny yutany yothuny yakun nhirpan Medicare cardlil.

Family Tax Benefit

You can get the Family Tax Benefit (FTB) if you:

- have a new baby
- have young kids in your care
- have kids in high school or approved study who are not getting a Centrelink payment.

You may also be able to get FTB if you are caring for a kid or kids that are not yours. This could be a kid or kids from your family who lives with you or you may be a kinship carer.

If you are going to have a baby, you can also start to get your FTB claim ready 3 months before your baby is born. This is called a pre-birth FTB claim.

When claiming FTB you need to give us:

- your Tax File Number (TFN) and if you have a partner, we need their TFN
- your Customer Reference Number (CRN)
- papers that show you are the carer for the kid or kids you are claiming for.

If you do not have a TFN, you can apply for one by visiting your local service centre or talking to Services Australia (Centrelink) when they visit your community.

If you have started your pre-birth FTB claim, we need the papers the hospital gives you after you have a new baby. We need these papers so we can finish your pre-birth FTB claim and also add your new baby to your Medicare card.

If you need more information you can:

- visit your local Services Australia (Centrelink) service centre
- talk to Services Australia (Centrelink) when they visit your community
- call the Indigenous Call Centre on 1800 136 380.

If you call us, you will need to tell us your Customer Reference Number (CRN) and answer some questions about who you are, so that we make sure it is you.

You can also ask for an interpreter when you call or visit us. We will provide one for free.
