



Family Tax Benefit

Nyuntu Family Tax Benefit (FTB) mantjilku nyanganyapa ngaranyangka:

- ititjararinganyi
- nyuntu tjitji kanyira pulkani
- nyuntumpa tjitji tjinguru kuulangka tjarpanyi munta kuula pulka nintiringanyi munuya Centrelink payment mantjilpai wiya.

Nyuntu tjinguru FTB mantjilku panyan tjitji tjuṯa kanyira pulkani nyuntumpa ngurangka. Tjinguru nyuntu nyuntumpa walytjaku tjitji panya kutaku, kangkuruku munta malanypaku tjitji tjuṯa kanyini munta tjinguru kinship care-tuanukulu.

Nyuntu tjinguru paku ititjara, ka panya FTB mantjintjikitjangku claim tjunama itinya ngarinyangka 3-months kuwaripangka. Ini nyanga paluru panya pre-birth FTB claim.

Nyuntu FTB claim tjungkula nyanga palunya nganananya ungama:

- nyuntumpa Tax File Number (TFN) munu nyuntu tjinguru kuritjara, palumpa TFN kulu-kulu
- nyuntumpa Customer Reference Number (CRN)
- pipa tjuṯa nganana nyakunytjaku nyuntu mulapa carer munun atunymananyi tjitji munta tjitji tjuṯa.

nyuntu tjinguru TFN wiya tjara. Nyuntu service centre-lakutu ara nyuntumpa ngurangka itingka munta Service Australia (Centrelink) waaka tjuṯangka wangkama tjana nyuntumpa kiminitikutu ma-pitjanyangka.

Nyuntu tjinguru pre-birth FTB claim kuwari palyani, nganana pipa nyakunytjaku mukuringanyi itinya ngarinyangka hospital-angku nyuntunya ungkunyangka pipa nyangantu

nganananya alpamilani pre-birth FTB claim tjunkuntjaku munula itiku ini tjunanyi nyuntumpa Medicare card-pangka kulu-kulu.

Piruku kulintjaku information nyanga palunya

- ara Services Australia (Centrelink) service centre-kutu ilangku kulintjaku
- nyuntumpa kiminitikutu Services Australia (Centrelink) waaka ma-pitjanyangka tjanela tjapila kulintjaku
- ringamilala Indigenous Call Centre nampa nyangangka: 1800 136 380.

Nyuntu nganananya ringamilara Customer Reference Number (CRN) ila kanyinma munu nganana question kutjupa-kutjupa tjuṯa nyuntunytjara tjapini lipula ngarantjaku.

Nyuntu mukuringanyi interpreter-taku, wangka utingku kulintjaku, nganana wangka kala interpreter mantjila nyuntumpa.

Family Tax Benefit

You can get the Family Tax Benefit (FTB) if you:

- have a new baby
- have young kids in your care
- have kids in high school or approved study who are not getting a Centrelink payment.

You may also be able to get FTB if you are caring for a kid or kids that are not yours. This could be a kid or kids from your family who lives with you or you may be a kinship carer.

If you are going to have a baby, you can also start to get your FTB claim ready 3 months before your baby is born. This is called a pre-birth FTB claim.

When claiming FTB you need to give us:

- your Tax File Number (TFN) and if you have a partner, we need their TFN
- your Customer Reference Number (CRN)
- papers that show you are the carer for the kid or kids you are claiming for.

If you do not have a TFN, you can apply for one by visiting your local service centre or talking to Services Australia (Centrelink) when they visit your community.

If you have started your pre-birth FTB claim, we need the papers the hospital gives you after you have a new baby. We need these papers so we can finish your pre-birth FTB claim and also add your new baby to your Medicare card.

If you need more information you can:

- visit your local Services Australia (Centrelink) service centre
- talk to Services Australia (Centrelink) when they visit your community
- call the Indigenous Call Centre on 1800 136 380.

If you call us, you will need to tell us your Customer Reference Number (CRN) and answer some questions about who you are, so that we make sure it is you.

You can also ask for an interpreter when you call or visit us. We will provide one for free.
