Sambala pipul gajim Income Management (BasicsCard or Green Card) or enhanced Income Management (SmartCard or Blue Card) langa Northern Territory gin gajim exemption.

Exemption imin yu noma labda abum BasicsCard or SmartCard en yu gin noma abum dubala unless samting tjeinj.

Ip yu garra beginini la yu keya alla taim, melabat luginat hau old dem beginini en wannim hepening. Mela garra toktokbat garra yu bla hau yu bin yujim yu mani du.

Ip yu beginini im lilwan en numu go la skul, mela maiti asgim yu bla joim dey bin:

- Abum alla nidul bla immunisation
- Abum sam tjekap la halth clinic
- Bin gugubat na pleigrup or childcare.

Ip yu beginini im gu na skul, mela maiti asgim yu bla gibit infomashin bla joim dey:

- Gugubat na skul, or
- Duimbat stadi or wekwek en gajim mani bla wek.

Mela garra della yu wat kain infomashin mela nid leigi:

- Immunisation nidul record
- Playgrup, childkeya, priskul, or skul bla hau mani taim im gugubat la skul.
- Leda bram yu docta or klinik garra alla health tjek

Exemptions from Income Management (BasicsCard) and enhanced Income Management (SmartCard) if you have children in your care all the time

Some people on Income Management (BasicsCard or Green Card) or enhanced Income Management (SmartCard or Blue Card) in the Northern Territory can get an exemption.

An exemption means you don't have to be on BasicsCard or SmartCard and you will stay off them unless your circumstances change.

If you have children in your care all the time, we look at your circumstances and how old your children are. We will also talk to you about how you are managing your money.

If your children are too young to go to school, we may ask you to give us information to show they have:

- had all their immunisations needles
- had regular health checks
- been going to play groups or childcare.

If your children are old enough to go to school, we may ask you to give us information to show they are:

- going to school, or
- doing studies or working and getting paid for working.

We will tell you what information we need like:

- immunisation needles records
- playgroup, childcare, preschool or school attendance
- a letter from a doctor or the clinic showing your child has had health checks.

If we ask for school attendance, your child's school can give you an attendance report. We may need more information if they haven't been going to school enough.

If we ask you to give us information, you will have 28 days to give it to us.

To ask for an exemption from BasicsCard, call the BasicsCard General Enquiry line on **1800 132 594**.

To ask for an exemption from SmartCard, call the SmartCard eIM hotline on **1800 252 604**.

Tell us if you need an interpreter and we will arrange one for free.

If your partner wants an exemption, they will need to talk to us about their options.
