Exemptions ngulaju yimiri karra nyampu kujaku Income Management (BasicsCard) manu enhanced Income Management (SmartCard) kajinpa-jana kurdukurdu mardarni care-ngka

Panukari yapa Income Management (BasicsCard yangka Green Card) manu marda enhanced Income Management (SmartCard yangka Blue Card) Northern Territory-rla ngula patulu-rlangu kaji kalu mani nyamputu exemption.

Nyampu exemption wangkami ka kaji-kanpa BasicsCard manu SmartCard-wangu nyinami ngaka kariki yangka kajinpa-nyarrpa karra nyinami.

Kajinpa-jana kurdukurdu, mardarni taarnngangu nyanyi kapurnarlu-nyarrpa karra kuja kanpa nyinami manu nyiya years old wati kurduju. Wangkami kapurnarlu-nyarra tala-kurlu, nyarrpa mani kuja kanpa.

Wita marda kurdukurduju kuja kalu nyinami, kuurlu-wangu, payirni kapunangu-kurlu information-iki milki-yirrarninjaku:

- immunisations needle-jangka nyurru
- kanyi warra kanpa health check-patu nyanjaku
- play group-patu manu childcare-kirra kuja ka yani.

Wiriwiri kurdukurdu-kurlu information milki-yirrarninjaku kuja kalu yukami junga kuurlula:

- yani kalu kuurlu-kurra, marda
- study-jarrimi kalu marda warrkingka pay karra.

Ngarrirni kapurnarlu-nyarra nyiya-piya mardaninjaku information:

- nyampu-piya immunisation needles record-patu
- nyampu-piya playgroup, childcare, preschool manu kuurlu attendance kirli
- letter nganta doctor manu clinic-jangka health check-patu milki-yirrarninjaku.

Kajinarlu-nyarra kuurlu attendance-iki payirni, kuurlulu yinyi kapurlu-nyarra attendance report kurdukuju. Kapurnarlu-nyarra payirni information-iki kaji lawa nyinami kuurlu-wangu.

Information nyampuku yinjaku, 28 days kapurnarlu-nyarra yinyi jangu-maninjaku.

Exemptions from Income Management (BasicsCard) and enhanced Income Management (SmartCard) if you have children in your care all the time

Some people on Income Management (BasicsCard or Green Card) or enhanced Income Management (SmartCard or Blue Card) in the Northern Territory can get an exemption.

An exemption means you don't have to be on BasicsCard or SmartCard and you will stay off them unless your circumstances change.

If you have children in your care all the time, we look at your circumstances and how old your children are. We will also talk to you about how you are managing your money.

If your children are too young to go to school, we may ask you to give us information to show they have:

- had all their immunisations needles
- had regular health checks
- been going to play groups or childcare.

If your children are old enough to go to school, we may ask you to give us information to show they are:

- going to school, or
- doing studies or working and getting paid for working.

We will tell you what information we need like:

- immunisation needles records
- playgroup, childcare, preschool or school attendance
- a letter from a doctor or the clinic showing your child has had health checks.

If we ask for school attendance, your child's school can give you an attendance report. We may need more information if they haven't been going to school enough.

If we ask you to give us information, you will have 28 days to give it to us.

Tell us if you need an interpreter and we will arrange one for free.

If your partner wants an exemption, they will need to talk to us about their options.
