Panukari yapa Income Management (BasicsCard yangka Green Card) manu marda enhanced Income Management (SmartCard yangka Blue Card) Northern Territory-rla ngula patulu-rlangu kaji kalu mani nyampuju exemption.

Nyampu exemption wangkami ka kaji-kanpa BasicsCard manu SmartCard-wangu nyinami ngaka kariki yangka kajinpa-nyarrpa karra nyinami.

Yangka kurdukurdu kajilparlu yantarla ngurra kari kurra, kaji kanpa mani exemption kajinpa:

- full time student marda apprentice
- warrki-jarrimi kanpa, warrki-jangka income wita mipanpa manu Centrelink-jangka. Payment manu-npa murntu palaku mipa nyampu 6 payment-patu-jangka nganimpa nyangu
- Special Benefit kalu-mani manu marda 16 manu kankarlu.

Mardanpa exemption-kurlu nyurru. Ngurrpanguju, ringi-mantalnganpa.

Exemptions from Income Management (BasicsCard) and enhanced Income Management (SmartCard) if you don't have children in your care all the time

Some people on Income Management (BasicsCard or Green Card) and enhanced Income Management (SmartCard or Blue Card) in the Northern Territory can get an exemption.

An exemption means you don't have to be on BasicsCard or SmartCard and you will stay off them unless your circumstances change.

If you do not have children in your care all the time, you may be able to get an exemption if you:

- are a full time student or apprentice
- are working and because of your work income you only got a little bit of your Centrelink payment for at least 4 of your last 6 payments from us
- get Special Benefit and are 16 or older.

Sometimes you might already have an exemption and you don't need to do anything. If you are unsure, you can call us to find out.

To ask for an exemption from BasicsCard, call the BasicsCard General Enquiry line on **1800 132 594**.

To ask for an exemption from SmartCard, call the SmartCard eIM hotline on **1800 252 604**.

Tell us if you need an interpreter and we will arrange one for free.

If your partner wants an exemption, they will need to talk to us about their options.
