



Pagament tad-Diżastru tal-COVID-19

Jekk int ħaddiem li tlift id-dħul minħabba l-ordni tal-moviment ristrett jew il-lockdown, int għandek mnejn tista' tirċievi l-COVID-19 Disaster Payment.

Jekk int resident Australian (Awstraljan), int trid tikklejma dan il-pagament onlajn. Int tinħtieg kont myGov illinkjat ma' onlajn akkawnt ta' Centrelink. Hu faċli biex tagħmel dan.

Ara li jkollok id-dettalji miegħek bħal ngħidu aħna kemm sigħat tax-xogħol tlift u l-ABN ta' min iħaddmek.

Jekk ma kklejmjtx pagament minn għandna qabel int trid ukoll ikollok provi tal-identità tiegħek. Tista' tagħmel dan kollu onlajn.

Int ikollok bżonn iddaħħal xi tagħrif dwarek stess kif ukoll xi tagħrif mid-dokumenti tiegħek tal-identità bħal ngħidu aħna ċ-ċertifikat tat-twelid Australian (Awstraljan) u l-liċenzja tas-sewqan tiegħek.

M'hemmx għalfejn iċċemplilna, aħna ser nibgħatulek SMS meta int titfa' b'suċċess il-klejm tiegħek.

Jekk għandek viża li tagħtik id-dritt li taħdem fl-Australia (Awstralja), int ser ikollok bżonn iċċemplilna fuq 180 22 66 biex tikklejma.

Jekk int eliġibbli, aħna ser niddepożitaw il-pagament dritt għol-kont bankarju tiegħek.

Meta tkun irregiſtrat għall-pagamenti rikorrenti awtomatiċi, int ser titħallas fi żmien 7 ijiem mill-bidu ta' kull perjodu ġdid tal-ikklejmar. Int mhux ser ikollok bżonn titfa' klejm ġdida minn dak in-nhar 'il quddiem.

Int mhux ser ikollok bżonn tiċċekkja magħna għajr meta jkun hemm dewmien ta' aktar minn 7 ijiem.

Ara li d-dettalji tal-kont tal-bank tiegħek huma preċiżi biex aħna nkunu nistgħu nħallsuk malajr kemm jista' jkun.

COVID-19 Disaster Payment

If you're a worker who lost income due to a restricted movement order or lockdown, you may be able to get the COVID-19 Disaster Payment.

If you're an Australian resident, you must claim this payment online. You'll need a myGov account linked to a Centrelink online account. It's easy to set these up.

Make sure you have details ready like how many hours of work you've lost and your employer's ABN.

If you haven't claimed a payment from us before, you'll also need to prove your identity. You can do this all online.

You'll need to enter some information about yourself as well as some information from your identity documents such as your Australian birth certificate and driver's license.

You don't need to call us, we'll send you an SMS when you successfully submit your claim.

If you hold a visa that gives you the right to work in Australia, you'll need to call us on 180 22 66 to claim.

If you're eligible, we'll make a payment straight into your bank account.

When you're registered for automatic recurring payments, you'll get paid within 7 days of the start of each new claiming period. You won't have to make a new claim from then onwards.

You don't have to check with us unless it has been more than 7 days.

Make sure your bank account details are correct so we can pay you as quickly as possible.
