

Fistulising Crohn's disease – continuing authority application

When to use this form	Use this form to apply for continuing PBS-subsidised biological agents for patients with complex refractory fistulising Crohn's disease.
Important information	<p>Continuing authority applications must be in writing and must include sufficient information to determine the patient's eligibility according to the PBS criteria.</p> <p>Applications for balance of supply can be made in real time using the Online PBS Authorities system or by phone. Call 1800 700 270 Monday to Friday, 8 am to 5 pm, local time.</p> <p>Call charges may apply.</p> <p>Under no circumstances will phone approvals be granted for continuing authority applications.</p> <p>Where the term 'biological agent' appears, it refers to adalimumab or infliximab.</p> <p>The information in this form is correct at the time of publishing and may be subject to change.</p>
Continuing treatment	<p>This form is ONLY for continuing treatment.</p> <p>After a written authority application for the first continuing treatment has been approved, subsequent continuing treatment with PBS-subsidised biosimilar brands of biological agents are Authority Required (Streamlined) and do not require authority approval from Services Australia for the listed quantity and repeats.</p>
Section 100 arrangements for infliximab i.v. only	<p>This item is available to a patient who is attending:</p> <ul style="list-style-type: none">• an approved private hospital• a public participating hospital, or• a public hospital <p>and is:</p> <ul style="list-style-type: none">• a day admitted patient• a non-admitted patient, or• a patient on discharge. <p>This item is not available as a PBS benefit for in-patients of a hospital.</p> <p>The hospital name and provider number must be included in this authority form.</p>
Treatment specifics	<p>The assessment of the patient's response to the course of treatment must be conducted within the time frame specified in the restriction. Where a demonstration of response is not conducted within the required time frame, the patient will be deemed to have failed treatment with that particular PBS-subsidised biological agent.</p> <p>A patient who has experienced a serious adverse reaction of a severity resulting in the necessity for permanent withdrawal of treatment is not considered to have failed treatment with that particular PBS-subsidised biological agent..</p>
