

## Purpose of this form

This form is used to confirm that you consent to your treating health professionals and/or health providers disclosing relevant information about your disability or medical conditions to the Australian Government Department of Human Services (the department), or assessors engaged by the department.

If more information is needed to assess your eligibility for Disability Support Pension (DSP) or employment services, the department or assessors engaged by the department may contact your treating health professionals and/or health providers to confirm or clarify information you provide about your disability or medical conditions.

This may include contact with any health professionals (including your treating doctor) and/or health providers who have examined, diagnosed or treated your disability or medical conditions which are relevant to your eligibility for DSP or employment services.

Your treating health professionals and/or health providers may be asked to disclose any medical information relevant to assessing your eligibility for DSP or employment services. This includes medical and specialist reports, clinical notes, medical records or other information, and any barriers that may affect your ability to work or participate in employment services or other assistance programmes.

Your treating health professionals and/or health providers may ask for confirmation that you have consented for them to disclose your medical information to the department or assessors engaged by the department.

You can complete the Consent to disclose medical information statement on this form to provide your consent, and the department will show this to your treating health professionals and/or health providers if requested.

You can withdraw your consent at any time by advising the department. However, if your treating health professionals or health providers do not disclose relevant medical information when requested, the department may not have enough information to assess your eligibility for DSP or employment services. This may result in your claim being rejected or your payment being stopped.

Unki kun ogeessoti fayyaa fii qaamootiin tajaajila fayyaa odeeffannoo waa'ee qaam-dhibama fii wal'aansa keetii Australian Government Department of Human Services, (Mootummaa Australia Damee Tajaajila Namoomaatti) yookaan gamaaggamtoota Damee kanaan ramadamanitti darbee akka kennamu hayyama kee kennuu dha.

Disability Support Pension (DSP) (Tajaajila Soor-bahiinsa Qaam-dhibamaa) yookaan Employment Services (Tajaajila Hujjiif) gahaa tahuu kee gamaaggammuuf odeeffannoon dabalaa yoo barbaachisee, Dameen kun, yookaan gamaaggamaan Damee kana jalatti hojjetu, ogeessota fayyaa fii qaamotii eegumsa fayyaa qumnamuun waa'ee kee mirkaneefachuu yookaan ibsa argachuu danda'u'.

Kunis ogeessota fayyaa si wal'aanani (kan akka doktora si wal'aanu) fii qaamotii eegumsa fayyaa fayyummaa kee xinxalan (examined), keessa dhibee keetii kan qoratani beekan (diagnosed), haala qaam-dhibama keetii fii wal'ansa fayyaa kan siif kennan qumnamanii Disability Support Pension (DSP) (Soor-bahiinsa Qaam-dhibamaa) yookaan Employment Services (Tajaajila Hujjiif) gahaa tahuu kee xinxaluuf odeeffannoo barbaachisu argachuu dabalata.

Disability Support Pension (DSP) (Tajaajila Soor-bahiinsa Qaam-dhibamaatiif) yookaan Employment Services (Tajaajila Hujjiitiif) gahaa tahuu kee mirkaneefachuuf ogeessotiin fayyaa fii qaamotii eegumsa fayyaa siin tajaajilan odeeffannoo kee gaafatamuu danda'u. Kunis gabaasota wal'aansa, tajaajila addawaa (specialist), qabsiisa mana wal'aansaa (clinical notes), odeeffannoo biro, dhibdee yookaan miidhaa yookaan sagantaalee gargaarsaa keessatti akka hin hirmaatne si dhorkuu danda'an dabalata.

Ogeessotni wal'aansaa fii qaamoliin eegumsa fayyaa kennan, odeeffannoon dhimma fayyaa kee Damee kanatti yookaan kanneen Damichaaf hojjetaniin akka dabarsamee ibsamuuf akka ati mirkaneesituuf si gaafachuu malu.

Dameen kun akka odeeffannoo fayyaa kee ogeessota fayyaati yookaan qaamolee eegumsa fayyaa kennan yoo gaafatan akka kennamuuf Unka Tole jechuu ibsa odeeffannoo wal'aansaa kana guutuu dhaan hayyamuu dandeessa.

Damee kana gaafachuu dhaan yeroo feetetti hayyama kee kana mulquu dandeessa. Haa tahu malee kan yoo ogeessotni fayyaa yookaan qaamootiin eegumsa fayyaa kennan yeroo gaafatamutti odeeffannoo wal'aansa kee kennuu yoo didan Dameen kun odeeffannoo gahaa waan hin arganneef Disability Support Pension (DSP) (Tajaajila Soor-bahiinsa Qaam-dhibamaa) yookaan Employment Services (Tajaajila Hujji) gahaa tahuu kee gamaaggamuu hin danda'u.
