

Consent to disclose medical information

Ogolaanshaha si loo sheego macluumaadka caafimaadka

Purpose of this form

This form is used to confirm that you consent to your treating health professionals and/or health providers disclosing relevant information about your disability or medical conditions to the Australian Government Department of Human Services (the department), or assessors engaged by the department.

If more information is needed to assess your eligibility for Disability Support Pension (DSP) or employment services, the department or assessors engaged by the department may contact your treating health professionals and/or health providers to confirm or clarify information you provide about your disability or medical conditions.

This may include contact with any health professionals (including your treating doctor) and/or health providers who have examined, diagnosed or treated your disability or medical conditions which are relevant to your eligibility for DSP or employment services.

Your treating health professionals and/or health providers may be asked to disclose any medical information relevant to assessing your eligibility for DSP or employment services. This includes medical and specialist reports, clinical notes, medical records or other information, and any barriers that may affect your ability to work or participate in employment services or other assistance programmes.

Your treating health professionals and/or health providers may ask for confirmation that you have consented for them to disclose your medical information to the department or assessors engaged by the department.

You can complete the Consent to disclose medical information statement on this form to provide your consent, and the department will show this to your treating health professionals and/or health providers if requested.

You can withdraw your consent at any time by advising the department. However, if your treating health professionals or health providers do not disclose relevant medical information when requested, the department may not have enough information to assess your eligibility for DSP or employment services. This may result in your claim being rejected or your payment being stopped.

Ujeeddada foomkan

Foomkan waxaa loo adeegsadaa si loo xaqiijiyo inaad u ogoshahay xirfad-yaqaanada caafimaadka ee daaweyntaada iyo/ ama bixiyeyaasha caafimaadka inay wixii macluumaad macquul ah oo ku saabsan iintaada ama xaaladda caafimaadkaaga u sheegaan Australian Government Department of Human Services (Wasaaradda), ama qiimeeyayaasha ay howlgalisey Wasaaraddu.

Haddii loo baahdo macluumaad dheeraad ah si loo qiimeeyo xaq-u-yeelashadaada Disability Support Pension (DSP) ama Employment Services, Wasaaradda, ama qiimeeyayaasha ay howlgalisey Wasaaraddu, waxay la xiriiri karaan xirfad-yaqaanada caafimaadka ee daaweyntaada iyo/ama bixiyeyaasha caafimaadkaaga si loo xaqiijiyo ama loo caddeeyo macluumaadka aad ka bixisay iintaada ama xaaladda caafimaadkaaga.

Tana waxaa ka mid ah xiriirka lala yeesho xirfad-yaqaanada caafimaadka (oo uu ku jiro dhaqtarkaaga ku daaweynaya) iyo/ama bixiyeyaasha caafimaadka kuwaas oo ku baaray, ogaadey ama kaa daaweeyey iintaada ama xaaladdaada caafimaad kuwaas oo khuseeya xaq-u-yeelashadaada DSP ama Employment Services.

Xirfad-yaqaanada caafimaadkaaga ee ku daaweynaya iyo/ama bixiyeyaasha caafimaadka waxaa la weydiin karaa inay sheegaan wixii macluumaad daaweyn ah oo khuseeya in la qiimeeyo xaq-u-yeelashadaada DSP ama Employment Services. Kaasna waxaa ka mid ah warbixinada daaweynta ama kuwa takhasusleyaasha, qoraalka bukaan-socod-eegtada, diiwaanada daaweynta ama macluumaadyada kale, iyo wixii caqabado ah oo saamayn kara awoodaada inaad shaqayso ama ka qaybgasho adeegyada shaqada ama barnaamijyada caawimaadka ee kale.

Xirfad-yaqaanada caafimaadkaaga ee ku daaweynaya iyo/ama bixiyeyaasha caafimaadka waxay codsan karaan xaqiijinta inaad u ogolaatay inay u sheegaan macluumaadka daaweyntaada Wasaaradda, ama qiimeeyayaasha ay howlgalisey Wasaaraddu.

Waxaad ku buuxin kartaa Ogolaanshaha si loo sheego oraahda macluumaadka caafimaadka foomkan si aad u bixiso ogolaanshahaaga, markaasna Wasaaraddu waxay tusaysaa xirfad-yaqaanada caafimaadkaaga ee ku daaweynaya iyo/ama bixiyeyaasha caafimaadkaaga haddii loo baahdo.

Waad kala noqon kartaa ogolaanshahaaga mar kasta adoo usoo sheega Wasaaradda. Si kastaba ha ahaatee, haddii xirfad-yaqaanada caafimaadkaaga ee ku daaweynaya iyo/ama bixiyeyaasha caafimaadka aysan soo sheegin macluumaadka daaweynta ee khuseeya markii laga codsado, Wasaaradda waxaa laga yaabaa inaysan hayn macluumaad kaafiya si loo qiimeeyo xaq-u-yeelashadaada DSP ama Employment Services. Taasina waxay keeni kartaa in dalabkaagii la soo diido ama lacag-bixintaadii la joojiyo.
